Stay Well and Keep Others Well This Holiday Season!

We ask that you stay home and worship with us virtually via our [SJU Worship Service Livestream](#) if you or a member of your household:

- have any symptoms of flu, RSV, pneumonia, or COVID-19, such as fever, chills, headache, cough, gastric distress, loss of smell, and shortness of breath;
- have tested positive for COVID-19 in the last 5 days; or

SJU Pastor Transition Update
from Debbie Parker, Chair of Council

Pastor Mary Ka's last day in the pulpit was January 7. The service was attended by 109 people in person and at least 10 households via our livestream! A reception followed with food, tributes, many thanks and well-wishes, laughter, tears, and a slide show recalling many Mary Ka moments.

Pastor Mary Ka's last official duty with SJU will be as moderator of the SJU Annual Congregation Meeting on January 21. Her new call begins February 1.

Presbytery and Church Council have approved my offer to continue to serve as Council Chair for one more year to see us through the pastor transition.

The Church Council is arranging to meet with an interim pastor candidate who is highly recommended by the Presbytery of Baltimore. The candidate is currently serving at another church and should be available in 3 months. In the meantime, the following people will serve in the pulpit through the end of January:

- January 14 – Guy Moody, Chair of SPRC and SJU representative to Baltimore Presbytery
- January 21 – Jackie Taylor, General Presbyter
- January 28 – Rev. Stephen Price-Gibson, PC(USA)

We are currently working to secure one or more pastors to bridge the gap from February through April.

We will have more information to share throughout January as the process moves forward, so stay tuned!

Required notice from BWCUMC

¶4015. Returning to a Previous Appointment.

1. As of the effective date of a new appointment, a pastor shall immediately cease all pastoral counseling and pastoral visitation with members or member families in the previous appointment. Since appointments are generally announced several weeks in advance, each pastor has adequate time in which to affect closure and make appropriate referral to another for the pastoral care of members.
2. Pastors shall have a clear understanding with former congregations that they will not return to officiate at baptisms, weddings, and funerals; or do pastoral counseling or pastoral visitation in that parish. Pastors, active or retired, shall respectfully decline to participate in such duties when invited by members of a former pastor. Declining all such invitations is the responsibility of the previous pastor. The present pastor, at his or her discretion, may invite the previous pastor to return for pastoral functions. However, the present pastor should never be under any pressure to invite the previous pastor.

Tell Congress: Save Oak Flat and Support a Just Energy Transition

[Oak Flat, or Chích’il Bił Dagoteel in Navajo \(Chéch’il Bił Dahoteel\)](#), is a sacred site for the San Carlos Apache. Unfortunately, this public land is facing imminent danger due to the detrimental impact of the mining industry. Sadly, Oak Flat is just one example of numerous public lands and vulnerable populations directly affected by the harsh extraction of resources.

As people of faith, it is our responsibility to protect our shared Earth and its inhabitants. We must act by urging political leaders to support the [Clean Energy and Mining Act of 2023 \(S.1742\)](#) and the [Save Oak Flat from Foreign Mining Act \(H.R.1351\)](#). The clean energy transition makes updating our mining laws more urgent than ever. This legislation will not only protect communities and the environment but also ensure that our supply chain is as sustainable as possible. In October, Grassroots moved its location to substantially expand its free, 24-hour crisis intervention, mental health, substance use disorder, housing support and suicide prevention services. Individuals and families can access enhanced walk-in crisis stabilization and related services, counseling, homeless services, resources and more at 8990 Old Annapolis Road, Suite A in Columbia. Additionally, the new location allows Grassroots to provide 24-7 urgent care, outpatient substance use disorder services, and mental health counseling and medication management to adults, adolescents, and children via an Outpatient Mental Health Clinic (OMHC). Our shelter programs will remain at our Freetown Road location where we are hoping to eventually increase capacity as well.

Columbia Community Care (updated 1-5-24)

The contributions of **non-perishable items** from Saint John the Evangelist Roman Catholic Church and St John United Church congregations at the WLIFC are greatly appreciated! For calendar year 2023, an estimated total of 13,728 items were contributed to Columbia Community Care from the WLIFC congregations through the office totes and WLIFC lobby. This compares to 17,297 items in CY2022 and 34, 306 items in CY2021. CCC and other groups find that in the months after the holiday season there is an increasing need for basic groceries and personal care items.

The CCC pop-up pantries serve an average of 300 families during their two-hour operation on Saturday mornings. These **non-perishable** food items are essential for the hundreds of families who have come to rely on the CCC pantries for weekly support. The season of need is always with us!
